Dear Mr. Young and Dr. Goldschmidt:

Pursuant to the authorities set forth in House Resolution 1367, the Task Force on the Attempted Assassination of Donald J. Trump (Task Force) hereby requests documents and information related to the coroner's report and autopsy report for Thomas Matthew Crooks. The Task Force has the authority to investigate and fully examine all actions by any ". . . state or local government, including state and local law enforcement; and . . . private entities or individuals."¹

On August 21, 2024, the Federal Bureau of Investigation (FBI) informed Members of the Task Force that Butler County and Allegheny County officials assisted in the recovery and examination of Crooks' body.² To assist the Task Force's investigation, please provide the following medicolegal records as soon as possible, but no later than September 6, 2024:

- 1. The coroner's report for Crooks, including all notes, photographs, and recordings of the coroner's initial investigation of the scene of death and Crooks' body;
- 2. The autopsy report for Crooks, including a list of all entities and individuals present at the time of the autopsy, as well as any related notes, photographs, and recordings;
- 3. The toxicology report for Crooks, including any related notes, photographs, and recordings;
- 4. All documents referring or relating to the recovery of Crook's body from the roof of the American Glass Research building; and
- 5. All documents referring or relating to the release of Crooks' body from the coroner's jurisdiction. To the extent such communications may have been oral, please provide a description of those communications.
